2 Product description

Receiver Plates are 96-well plates available with inserted filter frits of 10 $\mu m, 35~\mu m,$ or 50 μm pore size. They can be used for general filtration purposes as well as for retaining chromatographic resins (e.g., Protino® Ni-NTA Agarose, Protino® Glutathione Agarose 4B, Sephadex® G25, G50, or Sephacryl® S200). The Receiver Plates can be used under centrifugation using standard benchtop centrifuges as well as under vacuum. The plates are also offered with hydrophilized filter frits which enable the plates to be used additionally with gravity flow.
